


cancer cure with L-arginine

It was my great good fortune to run into the book "Forbidden Medicine" by Ellen Brown at about the same time that I developed skin cancer for the first time. After the cancer first appeared I looked on the Internet and discovered information about cancer but was hesitant to trust the information until I had received it from more than one source. When I heard that Ellen Brown had written a book about cancer I had to see if she described cancer the same way as the information I got on the Internet. There was agreement and I am convinced by this and by my experience with cancer that this book is accurate information. I am aware from my experiences with cancer that the book "Forbidden Medicine" is most likely an accurate description of the cause of cancer and of many cancer cures since using the information got rid of my cancer.
